### FLORIDA LAWS & RULES (4 PDH)

This course fulfills the requirement through a fast moving presentation by Ed Bayo. The class covers common problem areas in the law relating to the use of the seal certification by an engineer, adoption of the work of another engineer, the responsibilities of the engineer of record, the role of the prime professional and the delegated engineer and how misunderstandings may lead to charges of misconduct.

### DIGITAL SIGNATURE/ENHANCED PLANS AND ENVISION TRAINING (4 PDH)

#### DIGITAL SIGNATURE

FDOT's new Digital Delivery process will be discussed by addressing topics such as "what is in a digital delivery?," "what should the digital appearance look like?," "how are revisions handled?," compatibilities with popular software for processing PDF and more. Furthermore, the presentation will focus on future plans the FDOT has for digital delivery.

#### PRESENTER:

**Quinton Tillman, PE.**, Mr. Tillman has 25 years at Florida Department of Transportation (FDOT), where he currently works in the Engineering / CADD Systems Office. Since April of 2005, he has been responsible for state-wide development and support for the Professional's Electronic Data Delivery System (PEDDS). Moving beyond PEDDS, Quinton initiated a work group that implemented the Digital Delivery process in its current form using Public Key Infrastructure (PKI).

#### ENHANCED PLANS

Engineering Applications for Hyperlinked Portable Document Format (PDF) Files – This is an application of hyperlinked PDF files for engineering design and construction. Hyperlinked PDF engineering documents have the potential to: significantly reduce search time to locate project support data; promote efficient document navigation; enable practical paperless options; enable touch-ready plans on mobile devices; improve the archival value of documents and increase the overall return of the design investment. This presentation will overview the FDOT District 5 Enhanced Plans Pilot Study, describe the features of Enhanced Plans, demonstrate how to create Enhanced Plans using commonly held software, and discuss the merit and future of hyperlinked PDF files within the industry.

#### PRESENTER:

**Ryan Florence, PE.**, Mr. Florence is the Enhanced Plans Principal Investigator and serves as a Project Manager with AECOM. He has been involved in the design and management of major and minor roadway projects for the Florida Department of Transportation for over 11 years. He holds a Bachelor of Science in Civil Engineering from the University of South Florida.
