# **November 2015 Monthly Program**

# City of Tacoma Central Wastewater Treatment Plant Flood Wall Construction Project



Mr. Lance Bunch will be presenting a project which recently completed construction of a new flood wall for the City of Tacoma's Central Wastewater Treatment Plant. Lance Bunch is an Associate Engineer and Project Manager for the City of Tacoma's Environmental Services Department. He holds a Bachelor of Science degree in Civil Engineering from Washington State University (WSU). Prior to attending to WSU, Lance had a career as a Journeyman Millwright in the timber industry for 10 years.

The City of Tacoma's Central Wastewater Treatment Plant (CWWTP) is the most critical piece of wastewater infrastructure within the City of Tacoma. The CWWTP treats

approximately 80 percent of the City's wastewater. During wet weather months, this facility treats an average flow of about 30 million gallons per day. In a large winter storm event, the CWWTP can receive and treat over 130 million gallons of wastewater in a single day.

The CWWTP is located on the west bank of the Puyallup River in the Tacoma tide flats, where it is protected from routine flooding by a series of levees constructed by the U.S. Army Corps of Engineers. Despite the existing levee system, the CWWTP was still at risk from flooding due to possible overtopping of the levee system upstream of the CWWTP. To mitigate this risk, the City constructed a flood protection system. The flood protection system consists of approximately 2,700 feet of steel sheet piles extending 4 to 8 feet above grade with an additional 15 to 25 feet below grade. The presentation includes a tour of the new facilities.

# **Spotlight on Government Relations**

This month, I'd like to take a moment to talk about one of my favorite aspects of ASCE membership: government relations. Through ASCE, engineers like you and me have a voice to talk to our lawmakers on the local, State, and Federal level. You can do it through ASCE's Key Contacts Program (<a href="http://www.asce.org/keycontacts/">http://www.asce.org/keycontacts/</a>), thorugh committee membership on the local or national level, and through participation in section and state events such as legislative drive-ins or fly-ins. If you're really ambitious, you can even become a Congressional Fellow through ASCE. And many sections, including ours in Washington, have hired lobbyists to assist in government relations. The government relations program is robust.



Yet for its robustness, I don't see very many members take advantage of this opportunity. Indeed, my conversations with political canvassers and congressional aides confirm that civil engineers as a group are largely silent on political matters, despite the dire need for new and innovative legislation regarding infrastructure. I think that part of the silence is due simply to the nature of civil engineers as people – most of us aren't known as particularly outspoken or boisterous individuals – with some notable exceptions, of course. The other part of this inactivity, I speculate, is the idea that someone else will do it.

There are certainly national-level staff whose primary responsibility is government relations between the civi engineering industry and the government. But we all know that Federal legislation has been in gridlock over high-profile issues for years; and even if you never open your emails, you know that Congress puts infrastructure issues on the backburner over and over again. What's more, most of our national-level staff simply don't have the resources to focus on individual state legislation. That's where the sections come in.

The state of our nation's infrastructure has been highlighted in a humorous way by several television personalities – John Oliver and Stephen Colbert both have segments on infrastructure that are worth checking out (<a href="https://www.youtube.com/watch?v=Wpzvaqypav8">https://www.youtube.com/watch?v=Wpzvaqypav8</a> for John Oliver's coverage). John Oliver's segment highlights an important piece of the puzzle – take a look at the national response to the idea of raising the gas tax to revitalize the Highway Trust Fund. Not one positive vote came in on the call-in. If you're a legislator, would you endorse that bill? Now, think about our state legislature. Under immense pressure to cut taxes and fund pressing issues like schools, issues related to infrastructure funding are likely to go entirely unaddressed without some sort of voice.

And we must be that voice. If you and I don't do it, no one will. Our section is working with other Washington sections to plan a legislative event for 2016. But before we get to that point, we need to do our homework. We are actively looking for members who are interested in legislative matters as they pertain to our industry. I'll start – one of my topics of interest is the idea of street utilities. It is a fascinating and creative means of sustainably funding transportation infrastructure without relying on unpopular tax increases that could be "stolen" to fund other public functions. What a change that would be! Imagine – robust street maintenance, the ability to respond to citizen complaints, the ability to augment private development dollars and build the streets our communities deserve. Sounds like exactly the type of change that drove us to become who we are in the first place, doesn't it?

As educated professionals, can we really sit on the sidelines and have a legitimate complaint against our legislators when the only voices they hear are those of hysterical taxpayers and extremist advocacy groups? Is it any wonder our world is in disarray? It's time we added our valuable voice to the mix. You can get involved by contacting me or any of our section officers! Let us know your thoughts and passions!
