Transit COVID-19 Response Program Information Collection



- New FTA requirement in NTD ... TxDOT reporting for 5311-only agencies
- If you report urban and rural in NTD, you will report your own COVID information
- Survey monkey from TxDOT for April reports
- May revise PTN-128 for reporting in May and beyond

Transit COVID-19 Response Program Information Collection



- April 9 your first report due to TxDOT
 - Baseline 2 questions, one time only
 - Recurring 8 questions, monthly
- April 16 TxDOT first report due to NTD
- Due in the NTD by the 15th of every month thru December
 31 ... or until formal end of pandemic
